#### **Current COVID-19 Related 4-H Meeting Guidance**

Walworth County 4-H is required to abide by UW-Madison Division of Extension and Wisconsin 4-H COVID-19 meeting guidance. Guidance changes frequently due to the fluidity of the health situation in the state. Thank you for your continued patience and support as we all navigate these unprecedented times. Virtual and distance programs remain the preferred program delivery method. Volunteers may apply to conduct in-person programs with groups of 10 or fewer total people (youth adult). These must be pre-approved no matter where they are set to be held: indoors OR outdoors. Request a copy of the checklist from Janel Heidelmeier return it to her to start the approval process as far in advance of the program as possible. Approval takes a little time. Pre-event registration, notification and post-event reporting are required. Discuss plans for this with local staff. Some criteria for in-person programs include:

- Indoor gatherings are limited to 2 hours.
- 6 feet minimum distancing between participants is required at all times.
- Physical distancing is not required between members of the same household, however each member is counted in the maximum group size.
- Hand sanitizing equipment (soap and water is preferred, or hand sanitizer with at least 60% alcohol, tissues, and no-touch trash cans) must be readily available and frequently used.
- Face masks or coverings are typically required even when speaking.

#### WI 4-H Foundation License Plate Info

When you request 4-H Foundation license plates, you pay:

- \$25 annual donation; the donation may be deductible if you itemize your income tax returns
- \$15 issuance fee or an annual \$15 personalized plate fee, if requested
- The regular registration fee for your vehicle if your current plates expire within three months or you have no plates

At each plate renewal, you will pay the \$25 donation and the regular registration fee for non-personalized 4-H Foundation license plates. Packets are being sent out this week to all 4-H families for the next round of 4-H Family Challenge activities. There are more counties joining in on the road trip activities. The October packet includes enrollment info.

#### **New Business:**

Exec Board: The Board decided it would be good for all of the clubs have the same expectations. Each member should 1) enroll in at least one project, 2) participate in at least 50% of the club meetings held from time of joining, 3) create at least one product of project-based and learning and show it at the fair, to a leader, at a club meeting, etc., and 4) participate in at least one 4-H-sponsored community service activity.

The Executive Board also agreed to help fund program supplies and postage for the Extension office to help them out due to cut in spending. This was a \$2200 commitment at maximum.

4-H T-shirt orders are due September 30.

Fall Forum: Rick Thomas made a motion, seconded by Bill Marquart, to pay for 50% of the fee as long as the Jr. Leaders pay the other 50%. Motion carried.

Club Reports: Rick Thomas, Spring Prairie 4-H, said they are handing out yard signs and their club is having a reverse banquet donating food to the food bank. Another club is sending out packets of goodies to members.

There are several key leader positions that are open and need to be filled.

Next year's budget will be the same as this years, if you need more funds please put in your request to Kristi.
