SENIOR LEADERS' ASSOCIATION MEETING MINUTES October 28, 2024

Meeting called to order and pledges led by President, Rick Thomas at 7:08 pm.

OPENING ACTIVITIES:

Nine Jr. Leader youth ladies came to our Sr. Leaders to ask for Fall Forum scholarships. These participants included: Austyn Madaus, Natalie Baumeister, Jaena Baumeister, Rosemary Markham, Scarlett Kleist, Miss Leedle, Kathyryn, Tory (Whitewater 4H) and Rylee Alberman. Returning participants shared their interest in the educational workshops they personally chose and the friendships made with other youth from the state because 4H isn't just in Walworth County.

A vote was taken later in the meeting to award the recipients 1/3 the cost (1/3 full cost of \$185.00/per participant) of the trip with the understanding they are required to work a shift in the HOP next season. Motion was made to accept 1/3 award by Linda Giorno and Ed Schell.

Sr. Leaders Meeting Minutes: Rachelle Haacker

September minutes shared at the meeting were approved following motions by Jenny Schell and Paige Morgan.

Treasurer's Report: Renee Rieck

Renee shared that Sr. Leaders is awarded \$3.00 per 4H membership. This helps generate income among the other income categories of Quilt Raffle, Banquet Auction, House of Pork Fundraising, Wal. Co. 4H Foundation (limited access) and Misc. means as was later outlined in the Sr. Leaders 2024//2025 budget presented later on agenda.

Balances of accounts were Money market: \$8,581.29; Regular checking: \$7,437.71; Wal. Co. 4H Foundation Fund \$56,243.31, Programmed Funds: \$6,250.92 which leaves a full balance of \$114,318.73.

Renee also brought to our attention, at the disclosure of the bank, that our Money Market is an old account and if it were moved to a new current Money Market version, no fees or costs, it would be more lucrative. Motion to allow Renee to move the Money Market to a 20th century account was motioned by Diana Haeherlein and Rita VanSchyndel.

Approval of treasurer's report was motioned by Laurie Giorno and 2nd by Bill Marquart.

Sunshine Report: Bill & Doreen Marquart

Bill was unable to send Doug Amann a memorial gift due to needing some sunshine himself when becoming ill and hospitalized. With his recent health condition he will be unable to drive and so attending meetings will be difficult. Bill has offered to stay in the Sunshine position until someone is able to step forward and asks that all correspondence come via email or simply by calling him.

UW-Extension Report Summary:

Janel was unable to attend this month's meeting so the Extension report was referenced to the Blog. Please refer to the Extension website for all the details.

Concern about the May 1st deadline for 4H enrollment was discerned as not all inclusive with 4H projects. The animal projects require sooner involvement and meeting attendance that would not allow the member to participate if waiting til May 1 to enroll. It was encouraged to inform the public that exclusions for the fair might occur if enrollment occurs as late as May 1.

HOP Final Expenses

Laurie presented the final budget following the September Flea Market. Checks for \$6,500.00 each will be distributed to the Jr. and Sr. Leaders later this week. Outstanding bills include a CO₂ tank equaling approx. \$100.00 and possible trailer storage for 5 months at a fee near \$1,000 if more economical storage solution cannot be obtained. The ending balance in the account remains \$5263.06 for next year's preliminary expenses.

Laurie shared a few details from the committee meeting and the need to find a home for the grill and trailer. The grill and LP tanks will be shared at the VanSchyndel farm and transported by them as needed in the coming year. Bill Marquart may be able to store the trailer if the 30ftL x 11.5ftH x 8.5ft.W

Awards Committee:

Laurie, Linda, and Janel successfully went through the record books which were returned at the Sr. Leaders meeting. Members will be presented their awards at the November 15th Awards Reception. The committee is looking to revise the PPR so that it is easier to complete and follow.

Unfinished Business:

1) Sr. Leaders is also responsible for completing Charter paperwork and through conversations and recommendations, Rick proposed these three (3) goals to complete our charter:

A) Establish a committee to revisit/realign our districts

B) Explore other ways HOP could raise funds

C) Plan, prepare and host communication programs for the youth to build their confidence with presentation skills

Motion made by Jenny Schell and Andrea Rohloff to accept these goals was approved by all in attendance. Remember: All club charters are due Friday, November 1.

• Youth Building – Caroline held a rehash meeting prior to Sr. Leaders. She only received 8 surveys about the IPAD pre-fair judging and 1 exhibitor survey. Next year the QR code will go into effect so we will need to revamp our exhibit tags. This is the year to revise the 2-Year Fair book, so any concerns should be brought to Caroline prior to Dec. 1.

Caroline was disappointed with the Fair Board's response to the leaking happening at the Youth Building. The floor will not be raised at a cost of \$80,000, which is not the only solution for this construction issue. Caroline was asked to fill out a Building Maintenance form, but is instead considering a letter with petition signatures from 4H families to warrant the need for repair. Thank you Caroline for your labor of love!

New Business:

• Renee presented the 2024/2025 Budget that Diana and Janel helped revise. Budget included Income, Expenses subdivided into Program Activities, Trips, Project Support and Miscellaneous. Renee removed entries that had not received requests for over a year and let Sr. Leaders know that the Foundation Fund allows an expenditure of 4-4.5%

each year.

Motion to approve the budgets came from Laurie Giorno and Ed Schell.

Club/Project Group Reports:

No Reports shared.

Election of Officers:

Nominees for President, SE, SW and Central District Reps, and Sunshine were sought out. President nominee Rita VanSchyndel accepted and was unanimously cast as Sr. Leaders President. District Reps for the SE, Ashley Baumeister and Central, Caroline Corneilson have agreed to stay on. Jenny Schell, SW District, will let the group know next month if remaining on but encourages nominees to step forward. We are anticipating changes to assignments if a redistricting occurs. Nancy Lee was nominated for the Sunshine director and would like to consider giving her response in November.

Officer Installation will take place at the November 25 Sr. Leaders meeting which will begin at 6:45 pm. Meeting adjourned following motions made by Laura Leedle and Mr. Markham.
